**Re: Complaint against the Palestinian Football Association
and its President Jibril Rajoub for Breaching the FIFA Statutes
and Disciplinary Code**

Attached hereto is a copy of our letter and complaint prepared in conjunction with Palestinian Media Watch submitted to the FIFA Disciplinary Committee against the Palestinian Football Association (hereinafter: "PFA") and its president, Mr Jibril Rajoub.¹

As documented in the complaint, the PFA and Mr. Rajoub regularly and gravely breach the FIFA Statutes by **promoting and glorifying terrorism; inciting hatred and violence; promoting racism; and preventing the use of the game of football in order to build a bridge for peace**. The PFA and Mr. Rajoub are aided in this campaign by non-governmental organizations promoting discriminatory anti-Israel BDS (boycott, divestment, and sanctions). Several of these organizations are linked to the Popular Front for the Liberation of Palestine, a designated terrorist organization.

In the complaint we argue that the actions of the PFA and its president breach Articles 3 and 4 of the FIFA Statutes and Articles 53 and 58 of the FIFA Disciplinary Code.

It should be noted that based on the documentation referred to in the complaint, the German Olympic Sports Federation recently cancelled a 400,000 Euro, 2-year cooperation agreement with the PFA, because “sich nicht alle Partner zu den hohen Werten des Sports bekennen” [“not all partners are committed to the high values of sport”] [GOSF spokeswoman Ulrike Spitz, taz.de, March 28, 2017].

Considering the severe nature of the PFA and of Mr. Rajoub’s infringements, the Disciplinary Committee is requested to open proceedings against the PFA and Mr. Rajoub, and, where found necessary, implement disciplinary action **without delay, including:**

- For breaching Article 4 of the FIFA Statute - **suspension or expulsion.**
- For breaching Article 53 of the FIFA Disciplinary Code - **a match suspension for no less than twelve months and a minimum fine of CHF 20,000.**
- For breaching Article 58 of the FIFA Disciplinary code - **a match suspension for at least five matches and a minimum fine of CHF 30,000.**
- For breaching Article 3 of the FIFA Statutes penalties are not prescribed, but in accordance with Article 11 of the FIFA Disciplinary Code - **a ban on taking part in any football-related activity for an extended period of time.**
